### What recommendations would you propose for improving the examples sent with the email notice? |

#	Response
1.	I would like to see student experience related research as an option.
2.	Links (when provided) should be live and clickable and a feedback mechanism to ARUCC an the authors should be available as links die. Perhaps chunking into the student life cycle (versus for enrolment professionals) makes more sense as the registrarial function touches a person's life from cradle to grave.
3.	The examples provide a summary of related literature on a particular topic. You could also provide an example of an actual study with definitive conclusions.
4.	The templates provide excellent outlines for dealing with the various topics that are of concern to the ARUCC membership. With regard to the specific examples, the example for Template 1 (strategic issues) was thorough and helpful, definitely a resource I would consult. The example for Template 2 (operational/implementation issues) dealt with a topic that is of significant interest to me, but it seemed that some of the information that would have been really useful was missing from the actual example, even though it was recommended for inclusion in the template: 5. Provides suggestions for operational or implementation principles along with pros and cons; 6. Identify best or promising practices.
