Using a strategic enrolment management filter to identify solutions to the most challenging issues can be a key to ongoing student and institutional success in the coming years. |

Public and political pressure will have heightened for outcome-based evaluation of PSE, from student completion to knowledge transfer, employment and return on investment. |

These efforts are focused on harmonizing processes among Faculties and improving the University's planning, budgeting, and resource cost tracking capabilities. At the heart of these initiatives lies a custom web-based software application known as the Academic Resource Management (ARM) system. ARM is an application that coordinates instructor workload management, contract faculty hiring, graduate student utilization, and budget oversight. ARM has provided a mechanism to support integrated planning by linking curriculum with enrollments, full-time and part-time faculty complement and budget. Participants will learn how: Student data management systems can be integrated with other University systems to allow for integrated planning. Better integration of systems has allowed for streamlining of processes resulting in more timely information to students. Linking enrolment and budget allows Faculties to leverage real time data to support decision making related to cost/benefit of adjusting course space to better respond to student demand. |
